I am aware that by performing such jumps I am risking damage to my health. I hereby declare that I am healthy, both physically and mentally, and not under the influence of drugs or alcohol and therefore fully capable to perform the jumps. I shall follow the rules of the event, the instructions of the event assistants and the general safety rules that were explained to me in detail during the registration process prior to the start of the event.

I AGREE INJURIES MAY RESULT from jumping and I agree that I will not attempt any FLIPS that are above my ability level.

I AGREE TO FOLLOW THE INSTRUCTIONS OF THE EVENT ORGANIZERS & VOLUNTEERS AT ALL TIMES.
